## **AIM OF THE FELLOWSHIP**

To provide young farmers in South Australia with the opportunity to further their personal development. The Fellowship can be used for study tours, study courses or to assist in the initiation of a project.

## **THE SPONSORS**

The sponsors, the Agricultural Bureau of SA Inc., Primary Industries & Resources South Australia (PIRSA) and support from a PIRSA grant supporting Bureau Awards and Scholarships, offer a grant of up to \$8,000 for the Peter Olsen Fellowship For Young Farmers.

## **ELIGIBILITY**

This Fellowship is open to all Young South Australian Farmers between the ages of **18 and 35** who have been involved in farming as their principal activity for the past 12 months, and who have undertaken, are participating in, or are about to undertake further formal studies. Applicants must present their own applications.

## **FORMAT**

The winning Young Farmer will receive sponsorship in the form of a grant to achieve the Aims of the Fellowship. The Fellowship winner must access the Fellowship within a twelve-month period from winning the Fellowship.

## **SELECTION**

Selection will be based on the Fellowship applicants' abilities, achievements and motivation to succeed in agricultural, horticultural, or aquaculture industries.

The winner will need to demonstrate competency in a range of farming and interpersonal skills and will be expected to work within his / her chosen industry (enterprise) while holding the Fellowship.

## **SELECTION CRITERIA**

The selection panel will select a winner on the applicant's knowledge of Agriculture, Horticulture and / or Aquaculture and in the presentation of this knowledge.

Whilst the initial presentation of knowledge will be in the form of a written application, the Selection panel will also interview the finalists.

## **APPLICATIONS**

Applicants should address the following:

- Knowledge and understanding of their farming enterprise(s), and vision for its future
- Achievements
- What they hope to achieve from the Fellowship
- Presentation of the application.

An interview panel will question applicants on these aspects in the selection process

## **CONDITIONS**

Applicants must be between the ages of **eighteen (18) and thirty-five (35) years** when applying.

Applicants must be prepared to allow their names and photographs and any other information provided by them to be used in publicity associated with the Fellowship or any other Sponsor-generated publicity.

The Sponsors in conjunction with the Selection Panel reserve the right not to present the Fellowship in the event that none of the applicants are deemed suitable.

## **CONTRACT**

The selected applicant's eligibility for the Fellowship is subject to them entering into a formal contract with the Sponsors, the terms of which will include:

- **Timing**  
The recipient will take the Fellowship within twelve months of acceptance.
- **Expenses**  
The Sponsors do not accept any financial responsibility for expenses incurred by the Fellowship winner. The responsibility of the Sponsors is limited to funding the Fellowship.
- **Health**  
The successful applicant must give an undertaking that at the time of signing the contract they do not suffer from any ailments, or disabilities which might interfere with the completion of the Fellowship.
- **Insurance**  
The Fellowship winner is responsible for making adequate insurance arrangements including medical and other personal insurance.
- **Reports and Promotions**  
The Fellowship winner undertakes to submit a written report within in six months of completion of the Fellowship.  
The Fellowship winner is expected to speak to any individual or group of their experiences.
- **Responsibility**  
The Fellowship winner agrees not to hold the Sponsors responsible for any illness, accident, mishap, damage, or loss whether to person or property arising out of negligence of the Sponsors that may affect them during the period of the Fellowship, or as a subsequent result of it.

## **SPIRIT OF EXCELLENCE AWARDS NIGHT**

The Winner will be invited to attend the ABA's Spirit of Excellence in Agriculture Awards for the announcement and presentation of the Fellowship.

The Awards Night will be held on Wednesday 13<sup>th</sup> October 2010 at the Royal Coach Motor Inn, Kent Town.
